Dear Colleagues in Ministry:

As you are aware this year the Southern California Conference will hold its 64th Constituency Session on Sunday, May 17, 2015 at 7:55 a.m. at the White Memorial SDA Church.

Among the preliminary work toward such meeting the Bylaws Committee (BC) has the responsibility of reviewing the BYLAWS of the Conference, which is a key document to make it more relevant the conference constituency's interests and needs.

The current Bylaws document reads as follows:

8.1.2 Proposals for Amendments. At least three (3) months prior to a regular session, the committee shall announce a time and place for submitting written proposals for amendments to the committee for consideration and review. Such announcement shall be by written notice to (i) the pastors, (ii) the delegates, and (iii) the first elders. All proposals must be submitted in writing to the committee chair or conference secretary (for delivery to the committee) at least one (1) week prior to the meeting of the committee where such proposal will be presented and shall include the changes proposed together with an explanation for such proposal.

Accordingly, the BC has asked my office to inform you that this committee will be available to listen proposals for Bylaws amendments on Thursday, February 12, 2015 at 7:00 p.m. at the Conference office.

Following what this document states, any proposal/suggestion/recommendation for Bylaws changes should be sent ONE WEEK before of such meeting to the Chairman of the BC, Elder Greg Hoenes, using his email address (greghoenes@sbcglobal.net) or by regular mail through the attention of the SCC Secretary's office (1535 E. Chevy Chase Dr, Glendale, CA 91206).

Pastor, would you please forward this message to your First Elder and delegates (Regular and At Large) of your church? Should anyone of these people do not have an email address, you may copy this message for them. Thanks in advance for your cooperation in transmitting this message.
