

SESSION TIMELINE
(per Bylaws)

(The following dates are proposed for the Southern California Conference 64th Constituency Session in compliance with the current Bylaws.)

- October 16, 2014** Request **Churches elect Regular Delegates** according to their membership
("Regular delegates shall consist of the delegates from the churches, each church being entitled to a minimum of one (1) delegate, plus one (1) additional delegate for each fifty (50) members or major fraction thereof. BL 2.2
- January 5, 2015** **Delegates Selection** submitted by each organized church to the Secretary
("Each church shall elect its delegates in compliance with the Church Manual at a business meeting of the church and provide the information required under Section 2.2.2 not later than sixteen (16) weeks prior to the session.") BL 2.2.1
- February 15, 2015** **Pre-Session Committee**, consists of one delegate (Regular or At-Large) from each organized church; completes its work of selecting the Nominating Committee
("The pre-session committee shall complete its work not later than eight (8) weeks prior to the session and the secretary shall deliver (as provided in Section 12.19) the minutes of its meeting to all delegates within ten (10) days of such completion.") BL 3.1
- March 8, 2015** **Nominating Committee (NC)** commences its work
("The nominating committee shall commence its work not later than six (6) weeks ... prior to the session...") BL 3.2
- April 5, 2015** Nominating Committee renders its report to the Secretary
("... and complete its work not later than two (2) weeks prior to the session, at which time it shall report to the secretary.") BL 3.2
- April 7, 2015** Conference Secretary distributes Nominating Committee report to all delegates
("Upon completion of its deliberations, the nominating committee shall issue a report of its nominations to the secretary who shall distribute a copy to all delegates within two (2) business days following receipt.") BL 3.2.4
- April 19 & 20, 2015** Special Meetings of the Nominating Committee with those who request to meet the NC
("This report shall include the time and place of a special meeting of the nominating committee, which shall occur not more than seven (7) days prior to the session. BL 3.2.4

At this meeting delegates may appear to present comments to the report for the nominating committee's further consideration. BL 3.2.4
- May 17, 2015** **SCC 64th Constituency Session**
If the nominating committee shall elect to make any changes to its report prior to formal presentation at the session, any changes, together with the reason(s) for such change(s), shall be reported to the delegates.") BL 3.2.4

**Bylaws Committee
(TIMELINE)**

- January 22, 2015** Bylaws Committee ask delegates to submit their proposals for changes
- (*At least three (3) months prior to a regular session, the committee shall announce a time and place for submitting written proposals for amendments to the committee for consideration and review. BL 8.1.2*
- Such announcement shall be by written notice to (i.) the pastors, (ii.) the delegates, or (iii.) the first elders. BL 8.1.2*

- February 12, 2015** BC receives written proposals for Bylaws amendments
- All proposals must be submitted in writing to the committee chair or conference secretary (for delivery to the committee) at least one (1) week prior to the meeting of the committee where such proposal will be presented and shall include the changes proposed together with an explanation for such proposal.)* BL 8.1.2*

- March 15, 2015** BC submits its report to the Executive Committee
- (*The bylaws committee shall submit its report to the executive committee not later than eight (8) weeks prior to the session.)* B 3.3.2*
-
- March 26, 2015** Conference Secretary distributes the Bylaws Report to all delegates
- (*The secretary shall include any proposed amendments in the session report.)* BL 3.3.2*
- (*The secretary shall publish a session report, which shall include... bylaws... which will be distributed to all delegates as provided in Section 12.19.)* BL 3.3.3*

- May 17, 2015** BC reports to delegates at Constituency Session
- (*The bylaws committee shall submit a report to the delegates at the regular sessions.)* BL 8.1.1*

Proposed Agenda Items

- February 22, 2015** Submission of Agenda Items for the Session
- (*No later than twelve (12) weeks prior to the session, a church may submit to the executive committee proposed agenda items that have been approved by either a majority of its (i.) delegates, (ii.) church board, or (iii.) the church in business meeting. BL 3.3.1*
- The president, with the advice and consent of the executive committee, shall establish the agenda for the session.)* BL 3.3.1*
