RE: Proposed Items for the Session Agenda

The Southern California Conference Bylaws (Section 3.3.1) voted on May 15, 2011, reads as

followed:

3.3.1 *Proposed Agenda Items.* *No later than twelve (12) weeks prior to the session, a church may submit to the executive committee proposed agenda items that have been approved by either a majority of its (i) delegates, (ii) church board, or (iii) the church in business meeting. The president, with the advice and consent of the executive committee, shall establish the agenda for the session.*

My office is reminding you that your church can submit a recommendation for an item to be placed on the agenda for the upcoming Constituency Session. Any item submitted at the Session time, at the last minute, would be very difficult to be considered due to the Bylaws stipulations. For this reason, we invite you to present and discuss this matter with your church delegates, the church board and/or the entire church in business session.

The Conference Executive Committee will entertain any item submitted for consideration at its meeting on Tuesday, March 24, 2015. **However, agenda items for consideration must reach my office no later than Monday, February 23, 2015.**
